In January 2020, Dr. Albert assumed the Chair of the PDBNS, Dr. Shelly Anderson assumed the Vice-Chair position. At the first PDBNS meeting of the year, one minute of silence was observed to mark the passing of Dr. Sharieh Faghihi and Dr. Eric Hatfield. A bulletin was received from the office of the Chief Medical Officer of Health, Dr. Strang about a novel 2019 coronavirus...

A special bulletin was sent to all Registrants as a FYI.

On February 4th Dr. Gillis and Dr. Albert met with the honourable Randy Delorey Minister for DHW.

Dr. Albert, Dr. Walsh and Dr. Gillis attended the Professional Standards Authority (PSA) Conference in London England on March 5-6. This provided the opportunity to learn different approaches to deal with challenges which face health regulators, as well as network with other provincial and international health regulators. Dr. Gillis was a presenter at the conference.

Also presenting was Sir Harry Cayton the undisputed world leader in health care regulation. Many Provincial Ministers of Health in Canada are using "The Cayton Report" as a template when updating health legislation.

In March the Covid-19 Pandemic unfolded. The PDBNS focused on public safety. A Covid Team was assembled which brought in outside consultants for expertise in different domains.

Terms of Reference for this team were developed with direction from the Department of Health and Wellness as well as the Office of the Chief Medical Officer of Health Dr. Strang and his team.

The Covid-19 Team oversaw: 1) the shutdown of Oral Health Care delivery, 2) the safe and efficient delivery of emergency care through the set up of 8 emergency dental clinics throughout the province, 3) the resupply in PPE for these clinics.

In May Dr. Strang (CMOH) directed the oral health professions (Dentistry, Registered Dental Assisting, Dental Hygiene, Dental Technology, Denturists) to create a joint reopening plan. "The COVID-19 Return to Work Guidelines for Nova Scotia Oral Health Professions" was presented to Dr. Strang and Nova Scotia Occupational Health and Safety for approval.

Two webinars helped disseminate the new guidelines to oral health care providers.

All this required unprecedented collaboration, coordination and communication between all health care Regulators as well as their respective Associations.

Retrospectively the low case numbers of Covid 19 in the province shows that all the collective and individual hard work and sacrifice was not in vain.

Thank you and well done everyone!

Concurrent to the Pandemic, the PDBNS continued it's regular work. Dentists, registered dental assistants and corporations were registered. Complaints were received and processed.

Dental Practice Reviews resumed in August.

Committee work continued and produced new standards for Sedation, Obstructive Sleep Apnea and Cone Beam Computed Tomography.

The 1992 Dental Act is undergoing legislative amendments (the process that Government uses to make changes to legislation).

PDBNS has developed a discussion paper outlining 5 proposed concepts. This was sent to stakeholders for feedback in advance of a webinar presenting the proposed changes. A timeline has been struck that would have the process completed by the Fall of 2021. The new legislation will then be presented to the Legislative Assembly by the Minister of Health for approval.

The PDBNS has undergone an updating of it's Strategic Plan 2021-2023. The Operational Plan sees the completion of the New Dental Act as well as Regulations and By-Laws.

Two Board Members Dr. Chris Baker and Dr. Dave Dignan completed 9 years of service to the PDBNS. Both took on leadership roles during their term and did so at a high level. They are replaced by Dr. Sachin Seth and Dr. April Nason who commence their term under a Pandemic!

Report of the Complaints Committee 2020

During 2020 the Complaints Committee met on 5 separate occasions. There were 2 in person meetings; January 6 and March 2 and 3 meetings that took place via Zoom; September 18, November 18 and December 21.

Two of the meetings were held in an emergency capacity under section 34(1) of the Dental Act.

In urgent and compelling circumstances, the Complaints Committee may, without a hearing, in the interests of the public, immediately suspend the licence of a dentist or a dental assistant or may immediately impose restrictions on a temporary basis on the registration or licence, or both, of a dentist or dental assistant.

In both of these cases the committee voted unanimously to suspend the licence of each

dentist.

Each of the 3 remaining meetings were called as regular scheduled hearings. One to dispose of 2 complaints that had been tabled in 2019, another to dispose of 2 new complaints and another to deal with a settlement agreement arising as a result of the disposition of one of the new complaints.

In the end during 2020 the Complaints Committee made the following decisions;

- immediately suspended the licence of 2 dentists
- referred one complaint to the Discipline Committee which was subsequently resolved by a settlement agreement.
- issued 2 letters of reprimand both including future dental practice reviews.
- issued a council and included a future dental practice review.

For the 5 meetings that were called this past year two different panels were used. I would like to thank everyone involved for their professionalism, all their hard work and their ability to adapt in these very challenging times.

Report of the Mandatory Continuing Dental Education Committee 2020

The Mandatory Continuing Dental Education (MCDE) Committee of the Provincial Dental

Board of Nova Scotia (PDBNS) met for regular business on February 7, 2020. A special meeting to discuss an extension to the CE cycle due to COVID-19 was held on April 2, 2020. A second special meeting was held by Zoom on August 17, 2020 to discuss revisions to the MCDE guidelines to allow online/webinar CE credits.

Under the 2020 Audit Review process for the 3-year cycle ending December 31, 2019, a sample of 32 Registered Dental Assistants and 17 Dentists were randomly selected for audit.

Of the 32 RDA audits, 24 successfully completed the audit. One DA had been struck for failing to meet the continual practice requirement and advised the Board that she had not practiced since 1995. Another relinquished her license in April and if she decides to relicense will be required to provide her 36 hours of CE as a requirement to license. Of the 6 remaining incomplete audits, they were given until the end of 2020 to provide their CE and all have done so.

Of the 17 DDS audits, 12 were successfully completed. Of the 5 incomplete audits, 1 requires CPR course; 2 need to provide verification documents; 1 short CE hours and CPR course; 1 did not provide their log and supporting documents. The Registrar is now waiting on the 2 remaining dentists to submit their CE and will have to do so prior to November 30, 2021 in order to be able to renew their license.

At the special meeting in April, the MCDE committee approved a motion that RDAs and DDSs within the current audit 2020 cycle (Jan 1, 2017 – Dec 31, 2019) be given a one year extension to meet any shortfall in MCDE credit hours identified in the 2020 audit. Additionally, they recommended that deadlines for MCDE cycles ending on Dec 31, 2020, Dec 31, 2021, and Dec 31, 2022 be extended by one year.

At the special meeting in August the committee made recommendation to the PDBNS that guidelines be changed to allow for "Live Webinars" to count as Category 1 CE. Additionally, study clubs would be permitted to meet virtually. These changes were approved by the PDBNS at the September 2020 meeting.

Report of the Dental Practice Review Committee 2020

In January 2020 a stratified random sample set of 80 dentists was identified to complete the annual Dental Practice Review Self-Assessment document. As in previous years, Dr Sam Stewart of the Medical Informatics Division of the Faculty of Computer Science, Dalhousie University facilitated the sample selection: 1) initial random sample of 15% of eligible clinicians; 2) Second sample15% of initial sampling stratified by region.

The sampling resulted in:

- 1) 45 dentists from 296 eligible clinicians practicing in the Halifax Regional Municipality.
- 2) 14 dentists from 93 eligible clinicians practicing in the South Shore/ Valley/ Yarmouth region.
- 3) 21 dentists from 128 eligible clinicians practicing in the Cape Breton/ North Eastern region.

These clinicians received the 202 self-assessment document.

The practice review committee planned to meet on March 2020 to review the returned self-assessment documents. However, the Covid-19 pandemic changed those plans as all dental practices, with the exception of the designated emergency clinics, were closed from mid-March to the beginning of June, 2020.

With return to practice, Board committee work also resumed. Respecting health protocols, the committee met via Zoom on July 16, 2020 rather than the customary meeting at the Board office. The completed self-assessment documents were reviewed. Site visit locations were identified as well as incomplete or information deficient assessment documents.

A total of 13 sites were identified for site visits: 7 in HRM; 3 in Cape Breton/ North Eastern; and 3 in South Shore/ Valley/ Yarmouth.

Due to provincial Covid restrictions and guidelines, the visits were conducted by Dr. M. Gillis and Dr C. Grégoire. Prior to the site visits, the clinics' "Covid-19 Reopening Plan" were requested for review. Again, due to the restrictions, the process has been more laborious and lengthier. The goal is to have all 13 site visits completed by end of March 2021.

The review process was conducted with the support and cooperation of the members. Compliance was demonstrated with the recommendations to date.
